Pursuant to the provisions of Section 48-21-107 of the Tennessee Business Corporation Act (the "Act"), as amended, the undersigned domestic corporations adopt the following Articles of Merger:

1. The names of the corporations participating in the merger and the States under the laws of which such corporations are organized are as follows:

IMRAC Acquisition Company	Tennessee
Business Computer Applications, Inc.	Tennessee

2. The Agreement and Plan of Merger, dated as of June 30, 2005 (the "Plan of Merger"), by and among IMRAC Acquisition Company, a Tennessee corporation ("IAC") and Business Computer Applications, Inc., a Tennessee corporation and the holder of all of the issued and outstanding capital stock of IAC ("BCA"), is attached hereto as Exhibit A and is incorporated for all purposes into these Articles of Merger.

3. The name of the Surviving Corporation is Business Computer Applications, Inc.

4. The Plan of Merger and the performance of its terms have been duly authorized by all action required by the laws of the State of Tennessee. The Plan of Merger was properly adopted by the Board of Directors of IAC on JUNE 30, 2005, and by the Board of Directors of BCA on June 30, 2005. Pursuant to Section 48-21-105 of the Act, approval by neither the shareholder of IAC nor the shareholders of BCA is required.

5. The merger is to be effective upon filing of these Articles of Merger with the Secretary of State of Tennessee.
