## ASSIGNMENT OF TRADEMARK RIGHTS

THIS ASSIGNMENT AGREEMENT (the "Agreement") is between SunDog LLC, a Washington State Limited Liability Company having a place of business at 701st PL NW #4, Issaquah, Washington 98027 ("SunDog") and Sun Island International Inc., a Barbados Corporation, having a place of business at L Horizon, Gunsite Road, Brittons Hill, St. Michael, Barbados ("Sun Island").

### WITNESSETH:

WHEREAS SunDog LLC is a Washington State Corporation that sells sporting good containers and paraphernalia, including sunglass cases, backpacks, fanny packs, tackle bags, ski bags and tote bags.

WHEREAS Sun Island is a Barbados Corporation and markets sunglasses under the "SUNDOG" mark, worldwide, including in Washington State.

WHEREAS the parties have disputed their respective rights to use the name "SUNDOG" on or in connection with SunDog's sale of its sunglass cases and/or Sun Island's sale of its sunglasses and other eyewear.

WHEREAS, on or about February 14, 2007, SunDog and Sun Island entered into a Settlement Agreement which included, among others, a terms assigning to Sun Island the rights of SunDog in the trademarks "SUNDOG" and "SUNDOG and Design" for use in connection with "sunglass cases" (also called "cases for sunglasses").

NOW, THEREFORE, in consideration of entry into the Settlement Agreement and the License Agreement by Sun Island to SunDog, and other good and valuable consideration the receipt of which is hereby acknowledged, SunDog hereby transfers and

assigns all its right, title and interest in and to the SUND OG mark for use in connection with sunglass cases (also called cases for sunglasses), and confirms its February 14, 2007 assignment, as follows:

a. Assignment of SUND OG Sunglass Cases Trademarks.

SunDog hereby assigns all its right, title and interest in and to the SUND OG marks as used in connection with the portion of SunDog's business relating to the manufacture and/or sale of sunglass cases (the "Sunglass Cases Trademarks"), together with the goodwill of that portion of the business, including the priority rights therein and the right to apply for and receive registrations of the Sunglass Cases Trademarks, including any registration issuing from the divided out Sunglass Cases Trademark Applications, throughout the United States and in all other countries of the world, as well as the right to sue for and recover damages for past, present and future infringements of the Sunglass Cases Trademarks and registrations issuing thereon.

b. Assignment of SUND OG Sunglass Cases Trademark Applications.

SunDog hereby assigns all its right, title and interest in and to the Sunglass Cases Trademark Applications, Ser. No. 78/978,422 (SUND OG and Design - for "sunglass cases") and Ser. No. 78/671,814 (SUND OG - for "cases for sunglasses"), which have been divided out from SunDog's pending trademark applications for registration, Ser. Nos. 78/428,572 (SUND OG and Design) and 78/978,310 (SUND OG), respectively, together with the goodwill of that portion of SunDog's business relating to the manufacture and/or sale of sunglass cases symbolized thereby, including the priority rights therein and the right to apply for and receive

registrations throughout the world in the name of Sun Island or its successor, assign or representative, as well as any right to sue for and recover damages for past, present and future infringements of registrations issuing from the Sunglass Cases Trademark Applications, throughout the United States and in all other countries of the world.

IN WITNESS WHEREOF, the undersigned have caused their duly authorized representatives to execute this Agreement in the capacity shown below, to be effective as of the last date indicated below.
