**Confirmatory Assignment**

**THIS CONFIRMATORY ASSIGNMENT OF TRADE-MARKS** is by and between as the assignor, Royal Window Coverings (USA) L.P. ("Royal USA"), with its principal office at 14370 Myford Road, Suite 150, Irvine, California, 92602 and as the assignee, Royal Group Inc. ("Royal Group") with its principal office at 1 Royal Gate Blvd., Vaughan, Ontario, L4L 8Z7, Canada.

**WHEREAS**, Royal USA (formerly Novo Industries, L.P.) obtained rights to the trade-marks identified in Schedule A (the "Trade-marks") via a Contribution Agreement between Novo Industries, L.P., Novo Capital, Inc. and Steelewood Extruding Corporation (operating under the business name Allied Extrusions) dated December 31, 2000.

**WHEREAS**, Royal Group and 6714633 Canada Inc. entered into an Asset Purchase Agreement on March 26, 2007. This transaction included the sale and assignment of the Trade-marks from Royal Group to 6714633 Canada Inc. At the date of the assignment (March 26, 2007), the Trade-marks stood in the name of Allied Extrusions. The assignment was completed on the basis that the chain of title to the Trade-marks would be updated after the completion of the transaction.

**WHEREAS**, Royal USA and Royal Group desire to complete the actions necessary to update the chain of title to place the Trade-marks in the name of 6714633 Canada Inc.

**AND WHEREAS**, Royal USA wishes to confirm the assignment from Royal USA to Royal Group of all of Royal USA's rights in and to the Trade-marks;

**NOW, THEREFORE**, in consideration of good and valuable consideration, the receipt and sufficiency of which is acknowledged, Royal USA hereby confirms that as of March 25, 2007, it assigned and transferred to Royal Group of all of Royal USA's right, title and interest in and to the Trade-marks, including all its right, title and interest in and to registrations outlined in attached Schedule A, together with all associated goodwill of the business in connection with which the said Trade-marks have been used, the same to be held by Royal Group as fully and entirely as the same could have been held and enjoyed by Royal USA if this assignment had not been made, this including all rights of action accrued and to accrue in respect of the Trade-marks, including the assignment of the right to take action and recover in respect of any infringement of the rights of Royal USA that took place prior to the date of this assignment and the right to oppose any application to register a trade-mark which may be confusingly similar to the Trade-marks.
