1. Name. The name of the limited partnership is Madison Square Garden, L.P.

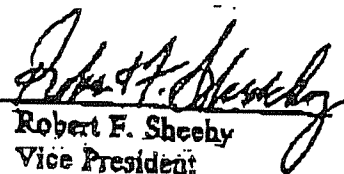
