**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of May 23, 2007, is made by The Bank of Nova Scotia (“Bank of Nova Scotia”), in favor of Venetian Casino Resort, LLC (“VCR”) as follows:

WITNESSETH

WHEREAS, pursuant to the Security Agreement, dated February 22, 2005 (“Security Agreement”), and recorded with The United States Patent and Trademark Office on March 9, 2005 at Reel/Frame No. 3043/0558, VCR granted Bank of Nova Scotia a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefor, including goodwill (the “Trademark Collateral”);

WHEREAS, the Bank of Nova Scotia acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement have been made;

WHEREAS, VCR has requested that Bank of Nova Scotia release its security interest in and to the Trademark Collateral, including without limitation the trademarks and all applications and registrations therefor set forth in Schedule A attached hereto and incorporated herein by reference.


