RELEASE OF SECURITY INTEREST
(Trademarks)

This RELEASE OF SECURITY INTEREST (Trademarks) (this "Release") is made and effective as of the 30th day of June, 2006 (the "Effective Date") and is granted by MARATHON SPECIAL OPPORTUNITY FUND, L.P., a Delaware limited partnership with an office at 461 Fifth Avenue, New York, New York 10011 ("Marathon"), in favor of AGS LLC, a Delaware limited liability company with an office at Three Embarcadero Center, Suite 2330, San Francisco, California 94111 (the "Releasee").


