**RELEASE AND TERMINATION  
(Trademarks)**

This Release and Termination (this "Termination") is effective as of May 18, 2007, by JPMorgan Chase Bank (f/k/a The Chase Manhattan Bank; "JPMorgan Chase").

**RECITALS**

A. In connection with the issuance of that certain Credit Agreement, dated August, 24, 2000 (as amended, the "Credit Agreement"), among Case Logic, Inc. (the "Company"), the guarantors party thereto, JPMorgan Chase, as agent and a lender, and the financial institutions party thereto as lenders (the "Lenders"), the Company granted to JPMorgan Chase, on behalf of itself and the Lenders, a security interest in certain assets of the Company, including, without limitation, those trademark registrations and applications listed on Schedule I attached hereto (collectively, the "Trademarks").

B. The Company paid off all of the obligations owed to JPMorgan Chase and the Lenders in full on September 24, 2004 and JPMorgan Chase has agreed to terminate and release its security interest in all of the Trademarks.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, JPMorgan Chase hereby terminates and releases its security interest in all of the Trademarks.
