TRADEMARK ASSIGNMENT

This Assignment Agreement is by and between Charlotte Moss & Co., a New York corporation with a place of business at 135 East 65th Street, New York, New York 10021 (“Assignor”) and TCJC Holdings LLC, a Delaware limited liability company with a place of business at 20 East 63rd Street, New York, New York 10021 (“Assignee”).

WHEREAS, Assignor is the owner of certain trademarks and trademark applications and a trademark registration identified in Exhibit A (the “Trademarks”);

WHEREAS, Assignor desires to transfer all rights, title and interest in and to the Trademarks to Assignee;

WHEREAS, Assignee desires to acquire all of Assignor’s rights, title and interest in and to the Trademarks;

WHEREAS, effective February 28, 2006, Assignor transferred and assigned substantially all of its assets, including the Trademarks, to Assignee.

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigns to Assignee, all of Assignor’s right, title, and interest in and to the Trademarks, together with the business, or portion thereof, to which the Trademarks pertain, the goodwill symbolized by use of the Trademarks, and the right to sue third parties for and recover damages from past and future infringement of the Trademarks.

All covenants and obligations herein shall be binding on and inure to the benefit of the Assignor, Assignee and their respective successors and permitted assigns.


Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to
