**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of June 7, 2007 is granted by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, located at 100 West Washington Street, Phoenix, Arizona 85003, as collateral agent (the "Collateral Agent"), in favor of FENDER MUSICAL INSTRUMENTS CORPORATION, FENDER INTERNATIONAL CORPORATION, AND JACKSON/CHARVEL MANUFACTURING, INC., all Delaware corporations, with their principal place of business located at 8860 E. Chaparral Road, Suite 100, Scottsdale, AZ 85250 (the "Releasees").

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of March 30, 2005, made by the Releasees in favor of the Collateral Agent (the "Pledge and Security Agreement"), a security interest (the "Security Interest") was granted, among others, in certain trademarks (the "Trademarks"), including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 30, 2005, made by the Releasees in favor of the Collateral Agent, (the "Trademark Security Agreement"), the Releasees by reference to the Pledge and Security Agreement, reaffirmed their intent to grant a Security Interest to the Collateral Agent specifically in the Trademark Collateral;

WHEREAS, the Security Interest was recorded in the United States Patent and Trademark Office on April 4, 2005, at Reel 003084 and Frame 0001; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Pledge and Security Agreement and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Releasees' right, title and interest as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto).

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges the entirety of its Security Interest in the Trademark Collateral, and any right, title or interest the Collateral Agent may have in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

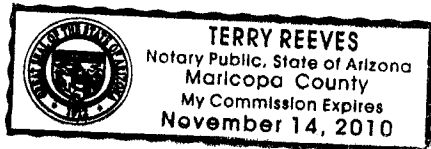
