RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of June 13, 2007 (this "Release") is made by The CIT Group/Business Credit Inc. ,acting in its capacity as collateral agent (together with any successor(s) thereto in such capacity, the "Agent") for each of the Secured Parties (as defined in the Security Agreement) under that certain Security Agreement, dated as of May 7, 2003 and recorded in the records of the United States Patent and Trademark Office, at Reel 2660, Frame 0287 (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among International Steel Group, Inc., ISG Acquisition Inc., ISG Cleveland Inc., ISG Hennepin, Inc., ISG Indiana Harbor Inc., ISG Warren Inc. ISG Riverdale Inc., ISG Plate Inc., ISG Sparrows Point Inc., ISG Piedmont Inc., ISG Burns Harbor Inc. W I T N E S S E T H

WHEREAS, pursuant to the Security Agreement which was recorded in the records of the United States Patent and Trademark Office, the Grantors granted to the Agent a security interest in the Trademark Collateral (as defined in the Security Agreement), including those set forth on the attached schedules;


