**TRADEMARK ASSIGNMENT  
AND  
DOMAIN NAME TRANSFER AGREEMENT**

This trademark assignment and domain name transfer agreement ("Assignment") is made effective as of May 22, 2007, from VeriSign, Inc. ("Assignor"), a Delaware corporation, having a place of business at 487 East Middlefield Road, M/S MV2-2-1, Mountain View, California 94043, United States of America, to Sedo.com LLC, ("Assignee"), a Massachusetts limited liability company, having a place of business at One Broadway, Cambridge, Massachusetts 02142, United States of America.

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement by and between Assignee, and Assignor and VeriSign Information Services, Inc. dated May 15, 2007 ("APA") whereby Assignee acquired certain assets related to Assignor's GreatDomains business;

WHEREAS, Assignor has used and is using in its business the trademarks set forth in Schedule A hereto;

WHEREAS, Assignor represents that it is the current registrant of the Internet domain names set forth in Schedule B hereto;

WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to the said Marks together with the goodwill of the business symbolized by the Marks and the registrations and applications therefor as set forth in Schedule A;

WHEREAS, Assignee is desirous of receiving the transfer of the registrations of the domain names set forth in Schedule B hereto;

WHEREAS, Assignee is desirous that the Assignment of the trademark applications and registrations for said Marks be made of record in the United States Patent and Trademark Office, and other appropriate Patent and Trademark Offices;

WHEREAS, Assignee is desirous that the transfer of said domain name registrations be made of record with the appropriate registrars;

NOW, THEREFORE, for receipt of the consideration set forth in the APA and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and intending to be legally bound hereby, said Assignor hereby assigns to said Assignee all rights, title and interest in and to the said Marks and transfers all registrations of said domain names, together with the goodwill of the business symbolized by the said Marks and domain names, and the applications and registrations therefor, as set forth in Schedules A and B, and all rights to damages and profits, due or accrued, arising out of past infringements of said trademarks and domain names, and the right to sue for and recover the same.

Assignor hereby covenants that it will, at the expense of Assignee, execute all documents, papers, forms and authorizations, and take all other actions that may be necessary for securing, completing, or vesting in Assignee of all right, title, registration, and interest in the Marks and for registering the domain names, including, without limitation, cooperating with Assignee to effectuate the assignment and transfer of the Marks and domain name registrations in foreign jurisdictions.
