**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks is granted and conveyed effective as of July 13, 2007 by The Royal Bank of Scotland PLC, a public company of the United Kingdom, having an office at 135 Bishopsgate, London, United Kingdom EC2M 3UR (hereinafter referred to as "RBS"), in favor of Doncasters Limited, a limited private company of the United Kingdom, having an office at 28-30 Derby Road, Melbourne, Derbyshire, United Kingdom DE73 1FE (hereinafter referred to as "Doncasters"), and Doncasters Medical Technologies Limited, a limited company of the United Kingdom, having an office at 28-30 Derby Road, Melbourne, Derbyshire, United Kingdom DE73 8FF (hereinafter referred to as "DMTL").

WHEREAS, the records of the United States Patent and Trademark Office ("PTO") reflect that RBS and Doncasters entered into a Security Agreement dated May 15, 2007 (the "Agreement"), under which Doncasters granted to RBS a security interest in Doncaster's interest in the trademark INTERPHASE, Registration No. 3125956 (the "Mark").

WHEREAS, the PTO recorded the security interest on May 30, 2007 at Trademark Reel 3551, Frame 0345;

WHEREAS, all of the outstanding obligations secured by the security interest have been satisfied and the parties seek to make a record of RBS' release to Doncasters of its security interest in the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, RBS hereby releases, discharges, and relinquishes its security interest in the Mark. RBS specifically acknowledges that the security interest is no longer effective, and that RBS does not own any rights to or have any ownership interest in the Mark and that any rights in the Mark as now owned by DMTL have also been released and discharged.
