RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 16, 2007 ("Effective Date") by and between **U.S. Bank National Association**, a national banking association, with an office at 60 Livingston Avenue, St. Paul, Minnesota 55107, as collateral agent for the Lenders ("Grantee"), and **Hickory Farms, Inc.**, a Delaware corporation, with its principal office at 1505 Holland Road, Maumee, Ohio 43537 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Collateral Assignment of Trademarks by and between Grantor and Grantee dated July 21, 2005 (the "Trademark Security Agreement"), and that certain First Amendment to Collateral Assignment of Trademarks by and between Grantor and Grantee dated July 21, 2005 (the "Amended Trademark Security Agreement," and together with the Trademark Security Agreement, the "Trademark Security Agreements"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreements pursuant to the terms and conditions of that certain Credit and Security Agreement dated June 30, 2000, as amended by the First Amendment to Credit and Security Agreement dated June 23, 2003, and as further amended by the Second Amendment to Credit and Security Agreement dated July 21, 2005, by and among Grantor, Grantee, and certain Lenders from time to time party thereto (the "Credit Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on July 29, 2005 at Reel/Frame 3131/0120;

WHEREAS, the Amended Trademark Security Agreement was recorded with the PTO on August 4, 2005 at Reel/Frame 3135/0064; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreements and the Credit Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedule A (attached hereto), in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
