FURTHER, and for the same consideration, Assignor agrees to sign all documents and perform any and all lawful acts necessary to record, register or perfect the rights conveyed hereunder. Assignee hereby accepts all of Assignor's rights, title and interest in the Mark and Assignee shall have the sole right and responsibility to record or register the rights conveyed herein and shall bear any and all costs associated therewith.
