## ASSIGNMENT OF TRADEMARKS

This AGREEMENT ("Agreement") is executed on this 06<sup>th</sup> day of June, 2007 by and between SAFRA NATIONAL BANK OF NEW YORK, national banking association chartered bank under the laws of the United States ("Assignor") and Safra Trademarks Holding Limited, a corporation organized and existing under the laws of the British Virgin Islands, having its offices at Marcy Building, 2<sup>nd</sup> Floor, Purcell Estate, P.O. Box 2416, Road Town, Tortola, British Virgin Islands ("Assignee").

**WHEREAS**, pursuant to an Assignment Agreement dated as of July 24, 2006 (the "Assignment Agreement"), Assignor is obligated to assign the Assigned Marks (as defined in the Assignment Agreement) that it owns to Assignee, as fully set forth in the Assignment Agreement; and

**WHEREAS**, Assignor is the sole and exclusive owner of all right, title, and interest in and to certain trademarks, service marks and domain names identified on Schedule A (collectively referred to herein as the "Trademarks") and

**WHEREAS**, Assignee is desirous of acquiring all right, title, and interest in and to all of the Trademarks and all goodwill connected with the use thereof, symbolized thereby, and associated therewith.

**NOW THEREFORE**, Assignor and Assignee agree as follows:

1. Assignor, subject to the retention of a reserved royalty-free license to use the Trademarks for a twenty-five year period, hereby sells, assigns, and transfers to Assignee, its successors and assigns all right, title, and interest (other than the retained license), if any, in and to the Trademarks, and all applications, registrations, and renewals therefor, together with all translations thereof, all goodwill symbolized thereby and associated therewith.

3. Assignor further agrees to execute upon the request of Assignee such additional documents as are necessary to continue, secure, defend, register, and otherwise give full effect to



and perfect the rights of Assignee under this Agreement and the Assignment Agreement in the Trademarks, and all applications, registrations, and renewals therefor, together with all translations thereof, in the respective country or countries, and the goodwill symbolized thereby and associated therewith.

4. Assignor hereby authorizes and requests that the Commissioner of Trademarks of the United States issue and record the title of Assignee as owner of all right, title, and interest (other than the retained license) in and to the Trademarks, all applications, registrations, and renewals therefor, together with the goodwill connected with the use thereof, symbolized thereby, and associated therewith.

5. All provisions of the Assignment Agreement are incorporated herein and govern this Agreement. Nothing herein is intended to modify, limit, or otherwise affect the representations, warranties, covenants, and agreements contained in the Assignment Agreement, and such representations, covenants, and agreements shall remain in full force and effect in accordance with the terms of the Assignment Agreement. In the event of a conflict between this Agreement and the Assignment Agreement, the provisions of the Assignment Agreement shall govern, supersede, prevail, and apply.

6. Unless otherwise defined herein, capitalized terms used herein shall have the same meaning as defined in the Assignment Agreement.




