ASSIGNMENT OF TRADEMARKS

This Assignment of Trademark is made as of October 28, 2002, by De-Sta-Co Manufacturing, an Arkansas corporation, the principal office of which is located at 1300 South Elmira, Russellville, Arkansas 72802 ("Assignor") and Stark Manufacturing of Arkansas, LLC, a New York LLC qualified to do business in Arkansas, the principal office of which is located at 1300 South Elmira, Russellville, Arkansas 72802 ("Assignee").

1. **RECITALS.** Assignor is the owner of the trademark "DOC'S BLOCKS" registered with the United States Patent and Trademark Office on June 11, 2002 under Registration Number 2578344 (hereafter "Trademark"). The Trademark identifies goods described as "automotive parts, namely blocks, fittings and tubing as replacement parts for automotive air conditioning systems" in International Class 012. Assignor's business involves the manufacture and sale of automotive parts. In connection with the sale of Assignor's business, Assignor's corporation is to be dissolved and the assets thereof to be transferred to Assignee, a newly formed LLC. Assignor desires to transfer Trademark to Assignee and Assignee desires to acquire the same.


2. **ASSIGNMENT.** Assignor hereby assigns to Assignee, its successors, assigns, and legal representatives its right, title and interest in and to the Trademark, as well as the right to recover any past infringements thereof, regardless of whether such infringements occurred before or after the date of this assignment. This grant further includes any rights of use.

3. **CONSIDERATION.** In consideration for the assignment set forth in paragraph 2, Assignee has paid Assignor the sum set forth in the business purchase agreement which Assignor acknowledges as received.

4. **FURTHER ASSURANCES.** Assignor further agrees to execute all documents as may be required to give effect to the terms of this Agreement and to cooperate with Assignee, its successors, assigns and legal representatives, in obtaining and presenting evidence in connection therewith or in policing or enforcing of the right to transfer hereby.


