To change the name of the Corporation.

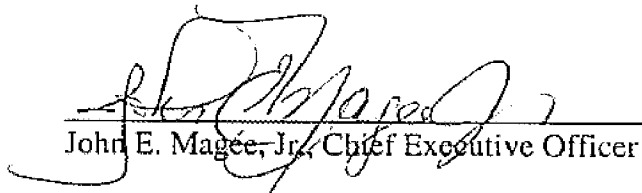
