

ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (this "Assignment") is made and entered into as of this [] day of May, 2002, by and among each of **STYLING TECHNOLOGY CORPORATION**, a Delaware Corporation, **STYLING TECHNOLOGY NAIL CORPORATION**, an Arizona Corporation, **U.K. ABBA PRODUCTS, INC.**, a California corporation, **FT. PITT ACQUISITION, INC.**, a Pennsylvania corporation, **FT. PITT-FRAMESI, LTD.**, a Pennsylvania corporation, **COSMETICS INTERNATIONAL, INC.**, a Wisconsin corporation, **BEAUTY PRODUCTS, INC.**, a Wisconsin corporation, (each a "Seller" and collectively, "Sellers" or "Styling"), and **JDS MANUFACTURING, INC.**, a California corporation, **EUROPEAN TOUCH, INC.**, a Wisconsin corporation, and **FRAMESI-USA, INC.**, a Delaware corporation, (each a "Styling Affiliate" and collectively, "Styling Affiliates"), and each Seller and Styling Affiliate, an "Assignor", and collectively, the "Assignors"), in favor of **ROUX LABORATORIES, INC.**, a corporation organized under the laws of New York whose principal office is located at 5344 Overmyer Dr., Jacksonville, FL 32205 ("Buyer"), for its benefit. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed thereto in the Asset Purchase Agreement (as defined below).

WITNESSETH:

WHEREAS, Sellers and Buyer are parties to that certain Asset Purchase Agreement dated as of March 26, 2002 (as the same may be amended, the "Asset Purchase Agreement") pursuant to which Buyer is to acquire all of the Assignors' right, title and interest in and to all of the domestic and foreign trademarks, applications, logos, service marks and trade dress and all goodwill associated with the foregoing comprised within the Transferred Intellectual Property (collectively, the "Assigned Trademarks"), including, without limitation, those Assigned Trademarks listed in Schedule I and Schedule II hereto.

NOW, THEREFORE, in consideration of the Purchase Price provided for in, and the other terms and conditions of, the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, the Assignors and Buyer each hereby agree as follows:

1. Assignment. Each of the Assignors hereby irrevocably sells, assigns, transfers, conveys and delivers to Buyer and its successors and assigns, and Buyer hereby purchases and accepts from each of the Assignors, all of such Assignor's right, title and interest in, to and under the Assigned Trademarks, including (for all purposes hereof), without limitation, all common law trademarks comprised within the Transferred Intellectual Property and for which no applications or registrations exist, all applications to register any of the Assigned Trademarks, and all registrations that have been or may be granted for any of the Assigned Trademarks, together with all common law rights associated with any of the Assigned Trademarks, and all past and present goodwill associated with the Assigned Trademarks and symbolized thereby, and all records and files related to the Assigned Trademarks, together with the right to sue and recover damages for future, present and past infringements of the Assigned Trademarks and the right to file, prosecute and maintain foreign applications under any convention or treaty with respect to trademarks and to fully and entirely stand in the place of the Assignors in all matters related to the Assigned Trademarks. With respect to each intent-to-use U.S. trademark application comprised within the Assigned Trademarks, the parties hereto acknowledge that the

portion of the business, which is ongoing and existing, to which such trademark pertains is also being transferred to Buyer pursuant to the Asset Purchase Agreement. This Assignment is intended to be an absolute assignment and not by way of security. This Assignment is in accordance with and is subject to all of the terms and conditions set forth in the Asset Purchase Agreement (which Asset Purchase Agreement shall govern in the event of a conflict between the terms hereof and those set forth in the Asset Purchase Agreement).

2. Further Assurances. From and after the date hereof, upon the request of Buyer or its successors or assigns, each Assignor shall duly execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, conveyances, powers of attorney and assurances as may be reasonably required to effect the terms of this Assignment or to carry out the transactions contemplated hereby. Assignors further agree to execute upon the request of Buyer such additional documents as are reasonably necessary or desirable to give full effect to and perfect the rights of Buyer under this Assignment in the Assigned Trademarks, and in the businesses of Sellers and Styling Affiliates to which the Assigned Trademarks pertain, which businesses are ongoing and existing, unless a particular Assigned Trademark has been abandoned or cancelled as indicated on Schedule II hereto. Each Assignor agrees that if Buyer is unable, after reasonable best efforts, to secure such Assignor's signature on any papers necessary to effect any of the foregoing, any executive officer of Buyer or any successor representative of the Assignors, for example, but not limited to, any trustee or agent appointed by the United States Bankruptcy Court for the District of Arizona to administer Assignors' estate, is entitled to execute such papers as such Assignor's agent and attorney-in-fact and each Assignor hereby designates and appoints such executive officer of Buyer or successor representative of Assignors as such Assignor's agent and attorney-in-fact for the purpose of taking those actions that Buyer, in its reasonable discretion, may deem necessary or desirable in order to protect its rights in any of the Assigned Trademarks. Such actions may be taken without any further consent from Assignors or any creditor of the Assignors. If the Assignors or Buyer should discover at any time after the date hereof the existence of any Assigned Trademarks that are comprised within the Transferred Intellectual Property that were not included in Schedule I or Schedule II ("Discovered Trademarks"), then the Assignors and Buyer promptly shall amend such Schedules to include such Discovered Trademarks and the Assignors shall cooperate with Buyer with respect to such Discovered Trademarks in accordance with this paragraph 2.

3. Recordation. Each Assignor hereby authorizes and requests that the Commissioner of Patents and Trademark of the United States issue to, and record in the name of, Buyer all right, title, and interest in and to the Assigned Trademarks, and the businesses of Sellers and Styling Affiliates to which such Assigned Trademarks pertain, which businesses are ongoing and existing, unless a particular Assigned Trademark has been abandoned or cancelled as indicated on Schedule II hereto.

4. Miscellaneous. Except to the extent the mandatory provisions of the Bankruptcy Code (as defined in the Asset Purchase Agreement) apply, this Assignment shall be governed by, and construed in accordance with, the laws of the State of New York applicable to contracts made and to be performed entirely in such state without regard to principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of New York applicable hereto. This Assignment may not be supplemented, altered or modified in

any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective parties and their assigns, transferees and successors. This Assignment and any amendments hereto may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute on and the same instrument.






