It has recently come to our attention that a previously recorded document was submitted with erroneous information affecting U.S. Registration No. 1569917. An assignment was recorded with the Patent and Trademark Office on May 22, 1990 at reel 0710, frame 0594, identifying the assignor as VIRGO PUBLISHING, INC. and the assignee as WESTERN SAVINGS AND LOAN ASSOCIATION, F.A.

At the time of recordation, VIRGO PUBLISHING, INC. did not have any right, claim, or interest in the above-referenced trademark, and we believe that the assignment was, therefore, erroneously recorded. We have made several failed attempts to contact the Attorney of Record who recorded said assignment.

Registrant respectfully submits that he is the owner the cited mark, the ownership of the mark never changed and any assignment recorded against the registration was erroneous. As such, Registrant respectfully requests that the record be updated to reflect the true owner of the mark.
