**AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

WHEREAS, SENARIO, LLC, an Illinois limited liability company, SENARIO LIMITED, a company organized under the laws of Hong Kong and SENARIO WORLDWIDE, LLC, a Delaware Limited liability company (together "Borrowers"), have adopted and are using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Borrowers are obligated to COLE TAYLOR BANK ("Lender") pursuant to (i) a certain Credit Agreement, dated the date hereof, among Lender and Borrowers and (ii) a certain Security Agreement, dated the date hereof, made by Borrowers in favor of Lender (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements");

WHEREAS, this Amended and Restated Trademark Security Agreement amends, restates and replaces that certain Trademark Security Agreement among the Borrowers and Lender dated as of March 16, 2005; and

WHEREAS, pursuant to the Agreements, Borrowers are granting to Lender a security interest in the Marks and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrowers do hereby assign unto Lender and grant to Lender a security interest in and to the Marks and registrations and applications therefor, which security interest shall secure all the Obligations (as defined in the Agreements) and in accordance with the terms and provisions thereof.

Borrower expressly acknowledges and affirms that the rights and remedies of Lender with respect to the security interest granted hereby is more fully set forth in the Agreements.
