TRADEMARK ASSIGNMENT

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record Assignee as assignee and owner of any and all of Assignor's rights in, to and under the Marks and to issue to Assignee any and all registrations resulting from said applications, or any renewals of said registrations.

Assignor further agrees without further consideration to cause to be performed such other lawful acts and to execute such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Marks and all other rights hereby conveyed.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, and may be executed and delivered by facsimile, and all of such counterparts and facsimiles together shall constitute a single instrument.
