ASSIGNMENT OF TRADEMARKS

WHEREAS, **UNIFIRST CORPORATION**, a Massachusetts corporation (hereinafter referred to as "Assignor"), is the owner of the United States trademark registrations listed on Exhibit A attached hereto and incorporated herein by reference (said registrations being hereinafter referred to as the "Marks"); and

WHEREAS, **UNIFIRST-FIRST AID CORPORATION**, a Maryland corporation having its principal business address at 10733 Tucker Street, Beltsville, Maryland 20705 (hereinafter referred to as "Assignee"), is desirous of acquiring the entire right, title, and interest of Assignor in and to the Marks and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, by these presents, does hereby sell, assign, and transfer unto Assignee all of its right, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, the same to be held and enjoyed by Assignee, for its own use and benefit and that of its successors and assigns, to the full end of the term for which said Marks are granted, together with all claims for damages by reason of past infringement of said Marks, with the right to sue for and collect the same for its own use and for the use of its successors, assigns, or other legal representatives.

Assignor does hereby covenant and warrant that: (i) it is the legal owner of said Marks and has full right and title thereto and authority to sell, assign, and dispose of the same; (ii) it has not granted any consent, right or license to use the Marks to anyone; (iii) there are no threatened or pending claims, protests, proceedings, or liabilities against Assignor involving the Marks; (iv) prior to execution of this deed, Assignor's right, title, and interest in said Marks has not been otherwise encumbered; and (v) it has not executed, and will not execute, any instrument in conflict herewith.

Assignor does hereby further covenant and agree with Assignee to execute and deliver such other and further instruments and take such other and further actions as may be reasonably necessary or appropriate to transfer said Marks, claims for damages by reason of past infringement, and right to sue and collect therefor to Assignee.
