TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("ASSIGNMENT") is made and entered into as of this 24 day of September, 2007, by and between Emerson Electric Co., a Missouri corporation ("Assignor"), and WF Acquisition, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor owns, has adopted and currently uses the marks identified on Schedule A attached hereto (the "Marks"), and owns other transferable rights associated with its ongoing and existing business including, but not limited to, the goodwill of the business associated with said Marks, and is the owner of all worldwide right, title and interest in and to the registrations and applications for registration for the Marks set forth in the attached Schedule of Trademarks (collectively the "Trademark Assets"); and

WHEREAS, pursuant to a certain Contribution Agreement made and entered into as of September 21, 2007, by and among Western Forge Corporation, Assignor, and Assignee, Assignor has agreed to contribute the Trademark Assets to Assignee.


NOW, THEREFORE, in consideration of the mutual covenants and obligations contained herein and in the Contribution Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


Assignor does hereby sell, assign, and transfer to Assignee, its successors and assigns, all of its right, title, and interest, in and to the Trademark Assets, together with any and all of the goodwill of the business symbolized by and associated with said Marks, and all income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of the Marks.

Assignor agrees to execute or procure any further necessary assurance of title to the Trademark Assets; and at any time, upon the request and at the expense of Assignee, will execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Trademark Assets in Assignee, its successors, assigns or other legal representatives; and to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Trademark Assets, and any and all goodwill associated therewith, and that Assignor no longer has any right, title or interest, of any kind or nature, in or to the Trademark Assets.


