TRADEMARK ASSIGNMENT

ASSIGNMENT made this 20 day of September, 2007, by and between Charles Pennington, having an address of 632 Wyoming Ave., Elizabeth, New Jersey, 07208 (hereinafter "Seller"), and Aquadry Systems, L.L.C., having an address of 177 Main St., West Orange, New Jersey, 07052 (hereinafter "Buyer").

Seller agrees that upon request by the Buyer that Seller shall execute all papers, make all rightful oaths, testify on behalf of Buyer and perform all other lawful acts necessary to carry out the intent of this Assignment at Buyer's request, as well as provide such other material, information, or assistance as the Buyer may deem necessary.

This Assignment shall be binding on the parties listed, their successors and/or assigns in interest, and all others acting by, with, or under their direction, all those in privity therewith.


