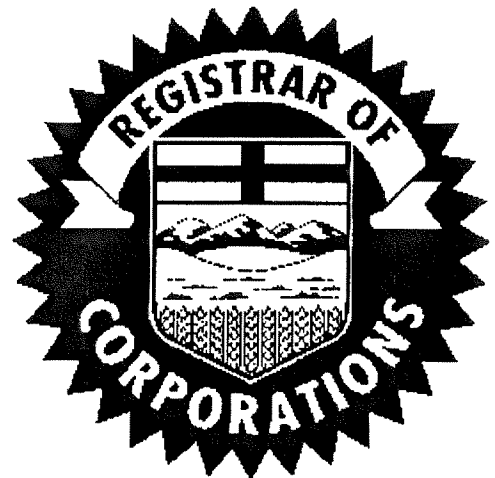

SCHEDULE RE TRANSFER RESTRICTIONS

No security of the Corporation, other than a non-convertible debt security, shall be transferred without the consent of the directors expressed by resolution or by an instrument or instruments in writing signed by a majority of the directors.

SCHEDULE RE OTHER PROVISIONS

Other provisions:

- (a) The Corporation shall be entitled to a lien on any share registered in the name of a shareholder or the shareholder's personal representative for a debt of that shareholder to the Corporation.
- (b) A holder of a fractional share shall be entitled to exercise voting rights and to receive dividends in respect of such fractional share.
- (c) The actual number of directors within the minimum and maximum number set out in these Articles may be determined from time to time by resolution of the directors.
- (d) The directors are authorized to appoint one or more directors, who shall hold office for a term expiring not later than the close of the next annual meeting of shareholders, but the total number of directors so appointed may not exceed one-third the number of directors elected or appointed at the last annual meeting of shareholders.
- (e) Meetings of shareholders may be held at such place:
 - (i) in Canada or the United States as the directors may determine; or
 - (ii) within or outside Canada as all the shareholders entitled to vote at that meeting so agree.
- (f) The liability of each of the Shareholders of this Unlimited Liability Corporation for any liability act or default of the Unlimited Liability Corporation is unlimited in extent and joint and several in nature.
