Whereas, ASA is desirous to buy the U.S. rights to the Mark "Staffwise" and Seller is willing to sell the rights to the Mark "Staffwise" to ASA.

Now therefore, parties hereto hereby agree as follows.

## ARTICLE 1 OBJECT

Object of the present agreement is the mark "Staffwise" as described comprehensively in the attached Annex 1 (hereafter "the Trademarks").


## ARTICLE 2 PURCHASE AND TRANSFER


- 2.1 The parties hereto agree that Seller shall sell and ASA shall buy the Marks with effect as of January 1, 2006.


