U.S. TRADEMARK SECURITY AGREEMENT

This U.S. TRADEMARK SECURITY AGREEMENT (this "Security Agreement"), dated as of October 24, 2007, by and between HLT Conrad IP LLC ("Pledgor"), a Delaware limited liability company, and BEAR STEARNS COMMERCIAL MORTGAGE, INC., a New York corporation, having an address at 383 Madison Avenue, New York, New York 10179, BANK OF AMERICA, N.A., a national banking association, having an address at Hearst Tower, 214 North Tryon Street, Charlotte, North Carolina 28255, GERMAN AMERICAN CAPITAL CORPORATION, a Maryland corporation having an address at 31 West 52nd Street, New York, NY 10019, GOLDMAN SACHS MORTGAGE COMPANY, a New York limited partnership having an address at 85 Broad Street, New York, New York 10004, MORGAN STANLEY MORTGAGE CAPITAL HOLDINGS LLC, a New York limited liability company, having an address at 1221 Avenue of the Americas, 27th Floor, New York, New York 10020, LEHMAN BROTHERS HOLDINGS INC., a Delaware corporation having an address at 745 Seventh Avenue, New York, New York 10019, and MERRILL LYNCH MORTGAGE LENDING, INC., a Delaware corporation having an address at 250 Vesey Street, New York, New York 10281 (each a "Co-Lender" and, collectively, "Lender").

WHEREAS, pursuant to Section 2 of the Mortgage Loan Intellectual Property Security Agreement and Collateral Assignment dated as of October 24, 2007 (the "Mortgage Agreement"; capitalized terms used but not defined herein have the meanings ascribed therein), Pledgor has pledged, granted, assigned and transferred to Lender, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Debt, a first priority security interest in all of its respective right, title and interest to and under, in each case, whether now owned or existing, or hereafter acquired or arising, in the Pledged Collateral, which includes the U.S. trademark registrations and applications set forth on Schedule A (the "Trademark Collateral"); and

WHEREAS, pursuant to Section 4(g) of the Mortgage Agreement, Pledgor has agreed to execute and deliver this Security Agreement to record the transactions contemplated by the Mortgage Agreement in the U.S. Patent and Trademark Office and to file (or cause to be filed) such Security Agreement in the PTO within ten (10) days after the date of the Mortgage Agreement;

NOW THEREFORE, for good and valuable consideration (including that recited in the Mortgage Agreement), the receipt and adequacy of which is hereby acknowledged, the parties agree as follows:

1. The parties confirm that, pursuant to Section 2 of the Mortgage Agreement, Pledgor has pledged, granted, assigned and transferred to Lender, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Debt, a first priority security interest in all of its respective right, title and interest to and under the Trademark Collateral.

2. The parties agree that this Security Agreement has been executed pursuant to Section 4(g) of the Mortgage Agreement for the sole purpose of recording the security interest granted in the Mortgage Agreement with the PTO and is expressly subject to the terms and conditions of the Mortgage Agreement. The Mortgage Agreement (and all rights and remedies of the parties therein) shall remain in full force and effect in accordance with its terms, and all such terms are incorporated herein by reference. In the event of any conflict between this Security Agreement and the Mortgage Agreement, the terms of the Mortgage Agreement shall govern.

3. Pledgor shall, from time to time, execute and deliver such further documents, instruments and agreements and take all such further actions as

Assignee may request and as may be necessary or desirable to evidence, perfect, preserve or protect the interest of Lender in the Trademark Collateral.

4. THIS SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF DELAWARE AND THE OBLIGATIONS, RIGHTS AND REMEDIES OF THE PARTIES HEREUNDER SHALL BE DETERMINED IN ACCORDANCE WITH SUCH LAWS.

5. This Security Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute one and the same instrument.






