Whereas, Assignor is the owner of the trademark(s) as described in **Exhibit A** attached hereto and incorporated by reference herein (the "Marks"); and


Whereas, Assignor wishes to assign his/her rights in the Marks to Assignee.

- 3. CONTINUING OBLIGATIONS:** Assignor agrees to assist Assignee, upon request, by taking any reasonable action that may be necessary for the perfecting, securing and completing of this Assignment.
- 4. BINDING EFFECT:** The covenants and conditions contained in this Assignment shall apply to and bind the Parties and their heirs, legal representatives and successors.
- 5. GOVERNING LAW:** This assignment shall be governed by and construed in accordance with the laws of the State of California.


