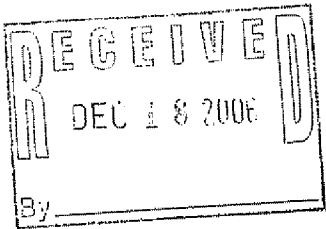

Under Section 803 of the Not-for-Profit Corporation Law

THE UNDERSIGNED, being the Secretary of CSICOP, Inc. (the "Corporation"), does hereby set forth:

FIRST: The name of the Corporation is CSICOP, Inc.

SECOND: The Certificate of Incorporation was filed by the Department of State of the State of New York on November 9, 1978. The Corporation was formed under §402 of the Not-for-Profit Corporation Law.

THIRD: The Corporation is a corporation as defined in §102(a)(5) of the Not-for-Profit Corporation Law. The Corporation is a Type B Corporation.


FOURTH: The amendment affected by this Certificate of Amendment is as follows: Paragraph **FIRST** of the Certificate of Incorporation, setting forth the name of the Corporation, is hereby amended to read in its entirety as follows:

"The name of the Corporation is Committee for Skeptical Inquiry, Inc."

FIFTH: The Secretary of State is designated as agent of the Corporation upon whom process against it may be served. The address to which the Secretary of State shall forward copies of process accepted on behalf of the Corporation is: 2300 Two Main Place, Buffalo, New York 14202.

SIXTH: The amendment of the Certificate of Incorporation set forth herein was authorized by majority vote of the members entitled to vote thereon by action of the members at a meeting.
