**NOW, THEREFORE**, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid to the ASSIGNOR, the receipt and sufficiency of which are hereby acknowledged, the ASSIGNOR does hereby sell, assign, transfer and convey to the ASSIGNEE, its successors and assigns, the entire right, title and interest in and to the Trademarks, together with the good will of the business in connection with which the Trademarks are used, including, without limitation, all rights in any causes of action, claims and demands and other rights for, or arising from, any past, present or future infringement, of the assigned Trademarks including, without limitation, the right to receive damages for the same, such rights to be held and enjoyed by the ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR if this Assignment and sale had not been made.
