## TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns and transfers to the Assignee Assignor's entire right, title, and interest in and to the Mark and in and to the goodwill of the businesses to which the Mark pertains and in connection with which the Mark has been used, and all of Assignor's rights and privileges pertaining to the Mark, including the right to sue and recover for past infringements.

Assignor agrees that it shall, at Assignee's expense, render all reasonable assistance to Assignee and will, from time to time, execute all instruments and documents reasonably necessary to maintain, preserve, or protect the Mark and the registration thereof and to perfect the record title of Assignee in and to the Mark.

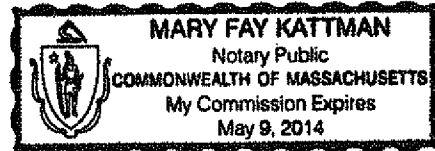
