R.S. 12:31 by the unanimous vote of the sole voting shareholder of the Corporation set forth in a Unanimous Consent of the Sole Shareholder, dated June 16, 2006.

The Acumen Group, Inc., constituting the sole shareholder of the Corporation, was represented in the Unanimous Consent in which the sole shareholder voted for the amendments.
