TRADEMARK ASSIGNMENT

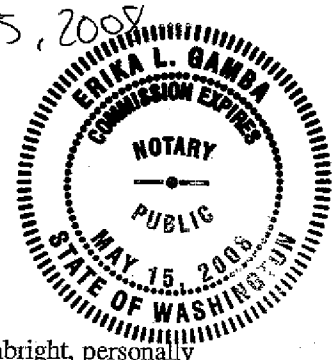
