TRADEMARK ASSIGNMENT

NOW, THEREFORE, for the sum of one hundred Euro (€100), which shall constitute good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, effective as of February 4, 2008, all right, title and interest that Assignor may have in the Trademark Rights (including any common law rights and the right to bring actions and claim relief in respect of any infringement or other violation of rights with respect to any of the Trademark Rights occurring prior to the date hereof), together with the goodwill of the business symbolized by the Trademark Rights; and

FURTHER, Assignor agrees that it will cooperate fully with Assignee in completing any further documents which shall be reasonably requested by Assignee in order to complete or record the assignment of its right, title and interest to the Trademark Rights.
