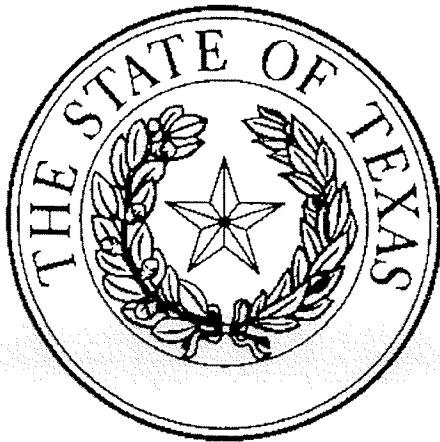

**ARTICLES OF AMENDMENT
OF
GTC TECHNOLOGY INC.**

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is GTC TECHNOLOGY INC. ("the Corporation"). The Corporation has a filing number of 800052067.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on September 29, 2004.

The amendment alters Article One of the original Articles of Incorporation, and the full text of each provision altered is as follows:

"Article One"

"The name of the Corporation is GTC TECHNOLOGY GP INC. ('the Corporation')."

ARTICLE THREE

The amendment has been approved in the manner required by the Texas Business Corporation Act and the constituent documents of the Corporation.
