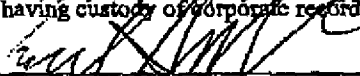

FIRST: The Second Amended and Restated Certificate of Incorporation of the Company is hereby amended by amending Article I to read in its entirety as follows:

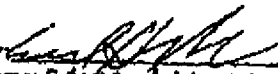
**ARTICLE I**
