**WHEREAS**, ASSIGNOR has adopted the trademark listed in Appendix A for which it owns a federal registration in the United States Patent and Trademark Office;


**WHEREAS**, ASSIGNEE is desirous of acquiring said trademark and any and all registrations therefor;
