**FIRST:** The names of the constituent entities are: United States Luggage Company, L.P., a Delaware limited partnership and United States Luggage Company I, LLC, a New York limited liability company.

**SECOND:** The date when the Articles of Organization of United States Luggage Company I, LLC were filed by the Department of State of the State of New York is June 2, 2006.

**THIRD:** The date when the initial Certificate of Limited Partnership of United States Luggage Company, L.P. was filed with the Secretary of State of Delaware is March 27, 1989. The date when an application for authority of United States Luggage Company, L.P. was filed with the Department of State of the State of New York is April 3, 1989.

**FOURTH:** The Agreement and Plan of Merger, dated as of June 26, 2006, has been approved and executed by United States Luggage Company, L.P. and United States Luggage Company I, LLC.

**FIFTH:** The name of the surviving domestic limited liability company is United States Luggage Company I, LLC, a New York limited liability company (the "Surviving LLC").

**SIXTH:** The Secretary of State of the State of New York is designated as agent of the Surviving LLC upon whom process against it may be served. The post office address within or without this state to which the Secretary of State of the State of New York shall mail a copy of any process against the Surviving LLC served upon him or her is: 400 Wireless Boulevard, Hauppauge, New York 11767.

SEVENTH: The merger is permitted by the State of Delaware and is in compliance therewith.

EIGHTH: The Agreement and Plan of Merger is on file at the principal place of business of the Surviving LLC at 400 Wireless Boulevard, Hauppauge, New York 11767.

NINTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving LLC on request and without cost to any member of the Surviving LLC or to any person holding an interest in United States Luggage Company, L.P.

TENTH: Upon the filing of this Certificate of Merger, Article "First" of the Articles of Organization of the Surviving LLC is hereby amended as follows:

"FIRST: The name of the limited liability company is United States Luggage Company, LLC."
