Assignor further agrees to cooperate with Assignee in the prosecution of the Trademarks by executing, verifying, acknowledging, and delivering all such further papers, including files in Assignor's possession for the Trademarks and perform such other acts as Assignee lawfully may request to obtain or maintain the Trademarks in any and all countries, and to vest title hereto in Assignee or Assignee's successors and assigns.

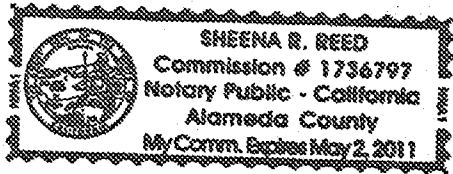
