TRADEMARK RELEASE, effective as of this 28th day of March, 2008, given by CITICORP NORTH AMERICA, INC., as Collateral Agent ("Agent") with principal offices at 290 Greenwich Street, New York, NY 10013, to Intertape Polymer Corp., a Delaware corporation, successor by merger to IPG TECHNOLOGIES INC., a Delaware corporation ("Grantor"), with principal offices at 2000 South Beltline Boulevard, Columbia, South Carolina 29201, as follows:

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor all rights, title and interest of Agent in and to the Marks set forth on Schedule A attached hereto, granted to Agent by the Grantor pursuant to the Security Agreement, which security interest was duly recorded on September 23, 2004, at Reel 003049, Frame 0887 in the United States Patent and Trademark Office together with the goodwill of the business symbolized by the Marks.


