ARTICLES OF ORGANIZATION OF ALL-AMERICAN BUYER, LLC

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 301 of the Iowa Limited Liability Company Act, the undersigned, acting as organizer of the limited liability company, adopts the following Articles of Organization for the limited liability company.

- 1. The name of the limited liability company is All-American Buyer, LLC
2. The street address of the limited liability company's initial registered office and the name of its initial registered agent at that office is: John Flaugh, 604 Locust Street, Suite 515, Des Moines, IA 50309
3. The street address of the principal office of the limited liability company is: 604 Locust Street, Suite 515, Des Moines, IA 50309
4. The existence of this limited liability company shall begin on the date its Articles of Organization are filed with the Secretary of State of the State of Iowa and the limited liability company shall have a perpetual duration.
5. The management of this limited liability company shall be vested in a manager or managers.

A manager of this limited liability company shall not be personally liable to the limited liability company or its members for monetary damages for any action taken, or any failure to take action, as a manager, except for liability for any of the following: (a) the amount of a financial benefit received by the manager to which the manager is not entitled; (b) an intentional infliction of harm on the limited liability company or its members; (c) a violation of Section 807 of the Iowa Limited Liability Company Act; or (d) an intentional violation of criminal law. If Iowa law is hereafter changed to permit further elimination or limitation of the liability of managers to the limited liability company or its members, then the liability of the manager of this limited liability company shall be eliminated or limited to the full extent then permitted.
