Release of Security Interest and Release of Collateral Assignment

Citizens Bank of Massachusetts ("Citizens Bank") is the successor in interest to the Security Agreement, and the underlying Obligations, between Julian's Cheesecakes, Inc. and Mellon Bank, N.A., entered into on August 4, 2000 and recorded with the United States Patent and Trademark Office at Reel and Frame Number 2151/0389.


The Security Agreement provided security for the underlying Obligations only and did not affect a true assignment and transfer of ownership in the below-referenced marks to Citizens Bank. Citizens Bank states that it never believed that it had an ownership interest in the marks, but rather a security interest only, and Julian's Cheesecakes, Inc. was and remains the sole owner of the below-listed trademarks.

Citizens Bank hereby confirms that Julian's Cheesecakes, Inc. fulfilled its Obligations and has paid off the loans associated with the Security Agreement. Pursuant to the Security Agreement, "upon payment in full of the Obligations, the Assignee shall reassign without recourse to Assignor all interest in the Trademarks and Trade Names that the Assignee received pursuant to this Agreement." Accordingly, to the extent any interest in the below-listed marks was assigned, Citizens Bank hereby releases, transfers and assigns all right, title and interest in the below-listed trademarks back to Julian's Cheesecakes, Inc.:
