QUITCLAIM ASSIGNMENT

The Smithfield Packing Company, Incorporated ("SPC"), of 111 Commerce Street, Smithfield, Virginia, 23430, hereby states as follows:

Stadler's Country Hams, Inc. ("Stadler's") was merged into SPC, and therefore SPC is Stadler's successor in interest. This merger is recorded at reel/frames 3692/0779 and 3693/0004.

On or about January 14, 2004 a change of name document regarding Stadler's, which had been executed on November 20, 2001, was erroneously filed against United States Trademark Registration No. 2,156,157, which had previously been assigned from Stadler's to Mr. Raymond Svobodny on September 12, 1997 (see reel/frame 1637/0001.) SPC has no present ownership interest in Registration No. 2,156,157.
