RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK APPLICATIONS

This Release of Security Interest in Certain Trademark Applications, dated as of December , 2007 ("Release"), is made by Citibank, N.A., as administrative agent ("Secured Party"), in favor of Unisys Corporation ("Grantor").

WITNESSETH:

WHEREAS, pursuant to (a) a Security Agreement, dated May 31, 2006, (b) an Intellectual Property Security Agreement, dated May 31, 2006 and (c) an Intellectual Property Security Agreement Supplement, dated March 2, 2007 (the "Security Agreement Supplement"), Grantor granted a security interest in certain registered intellectual property (the "IP Collateral") in favor of Secured Party; and

WHEREAS, the IP Collateral referenced in the Security Agreement Supplement includes two (2) U.S. trademark applications: application nos. 78/920,914 and 78/920,900 and any resultant trademark registrations (the "Released Applications"); and

WHEREAS, the Security Agreement Supplement was recorded with the U.S. Patent and Trademark Office on April 13, 2007 at Reel/Frame 3528/0385; and

WHEREAS, Grantor has requested that Secured Party release its security interest in the Released Applications.

NOW, THEREFORE, in consideration of the premises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Secured Party hereby releases, without recourse, representation or warranty of any kind, any and all right, title and interest to its security interest in and to the Released Applications.
2. This Release shall be effective only with respect to the Released Applications, and nothing contained herein shall be deemed to be a release or termination of or have any other effect on any other liens, security interest, charges or encumbrances on any other IP Collateral, property or assets granted by the Grantor to the Secured Party.
