Assignor agrees to execute such further documents as may be required to record Assignee as the owner of the Trademark herein assigned.

This Trademark Assignment may be executed in one or more counterparts, none of which need contain the signature of more than one party hereto and each of which shall be deemed to be an original, and all of which together shall constitute a single agreement.



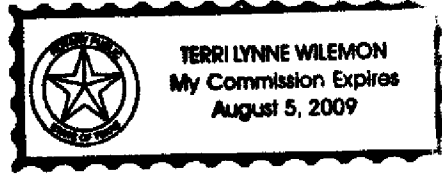
