**FIFTH AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
THE CORDUS CORPORATION**

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of **THE CORDUS CORPORATION** (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **THE CORDUS CORPORATION**.

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

"The name of the corporation shall be: **CORD:USE CORD BLOOD BANK, INC.**"

THIRD: The foregoing amendment was adopted by the unanimous written consent of the Board of Directors dated November 8, 2006, and shareholder approval was not required.
