## RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST is made as of May 23, 2008, by and between Wachovia Bank, National Association, in its capacity as ABL Collateral Agent pursuant to the Credit Agreement dated as of July 20, 2007 ("Lender") and Vistar Corporation, a corporation formed under the laws of Colorado (individually and as successor-in-interest to Roma Food Enterprises, Inc., a corporation formed under the laws of New Jersey, collectively, "Debtor") with reference to the following:

A. Pursuant to a Trademark Security Agreement, dated as of July 20, 2007, Debtor granted to Lender a lien on and security interest in trademarks owned by Debtor and listed on Exhibit A attached hereto (the "Trademarks");

B. Lender's lien on and security interest in the Trademarks was recorded with the United States Patent and Trademark Office on (i) August 15, 2007 at Reel 003601, Frame 0865 and (ii) April 4, 2008, at Reel 003752, Frame 0944.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Lender hereby acknowledges and confirms the full and complete satisfaction of Debtor's indebtedness under the Security Agreement with respect to the Trademarks and hereby waives, releases, relinquishes, and abandons any and all rights, obligations, liens or security interests, and any and all claims of liens or security interests, of any kind or nature, in and to any of the Trademarks, and Lender hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office Trademarks to release the security interest in favor of Lender.

Lender agrees to execute such other documents and assurances as may be reasonably necessary to carry out the intent of this Release of Security Interest.

This Release of Security Interest shall be binding upon Lender and its successors and assigns.
