  - (c) to perform all other acts which may be reasonably necessary or desirable to defend or obtain a grant of a registration for said Trademarks in any country throughout the world.

2. The ASSIGNOR covenants and warrants that it has full right to convey the entire title, and interest by this instrument, free of any encumbrances, and that no other agreement has been or will be executed in conflict herewith.
