# ASSIGNMENT

This AGREEMENT, made as of the 20 day of May, 2008

## BETWEEN

**360 DEGREE WEB LIMITED.** organized under the existing laws of U.S.A., having a business place at Huntlaw Building, P.O. Box 2804, Georgetown, Grand Cayman, Cayman Islands, and referred to as "the Assignor"; and

**O2MICRO INTERNATIONAL LIMITED.** organized under the existing laws of Cayman Islands, having a business place at The Grand Pavilion West Bay Road, P.O. Box 32331 SMB, George Town, Grand Cayman, Cayman Islands and referred to as "the Assignee",

**WHEREAS**, the Assignor is the owner of, and has adopted, used and is using in commerce, the two trademarks "360 WEB", "360 DEGREE WEB"; "PLATINUMKEY"; "PLATINUMSECURE"; "PLATINUMPAS" and "PLATINUMSECRET" for the goods/services categorized into International Classes 9;

## WHEREAS,

- 1) The Assignor is the registered proprietor of Trademark Registrations ("the Registrations") of the two trademarks "360 WEB", "360 DEGREE WEB"; "PLATINUMKEY"; "PLATINUMSECURE"; "PLATINUMPAS" and "PLATINUMSECRET" ("the Trademarks") details of which are set out in Schedule I;
- 2) The Assignor wishes to assign "the Registrations" to the Assignee upon the terms hereinafter appearing.

## NOW IT IS HEREBY AGREED as follows:

- 1) In consideration of the sum of one US dollars (USD1) and the other good/valuable consideration (the receipt of which is hereby acknowledged by the Assignor), the Assignor as beneficial owner hereby assigns to the Assignee:
  - a) the Registrations,
  - b) the goodwill in the business in the goods specified in the Registrations; and
  - c) the right to institute and to maintain proceedings for passing off or trademark infringement against any person who in the past has wrongfully used or now or hereinafter wrongfully uses the Trademarks.

TO HOLD unto the Assignee absolutely,

- 2) The Assignor covenants that it will at all times hereafter do all such acts and execute all such documents as may reasonably be necessary or desirable or both to secure the vesting in the Assignee of all rights assigned to the Assignee hereinunder and to assist in the resolution of any question concerning the Trademarks.
