The undersigned Carlo Marchetti, notary in Rho, registered in the notarial College of Milan,

certify that

by my deed of 12 December 2006 n. 2421/1182, the company "Filivivi S.r.l." having seat in Milano, Via Turati 16/18, fiscal code and registration number in the Companies' Register of Milan 04816000964, has incorporated by merger the company "Lanerossi Filati S.r.l." having seat in Montecchio Maggiore frazione Alte Viale Trieste 62, registration number in the Companies' Register of Vicenza and fiscal code: 01818460968.

The merger deed was registered in the Companies' Register of Vicenza on 18 December 2006 for the merged company (Lanerossi Filati S.r.l.) and in the Companies' Register of Milan on 19 December 2006 for the merging company (Filivivi S.r.l.).

The merger was valid towards third parties, made the inscriptions according to art. 2054 bis cod. Civ., starting from 31 December 2006.

Therefore, starting from the merger validation date, i.e. from 31 December 2006:

- the merging company "Filivivi S.r.l." modified art. 1.4 of the company statute (scope) and adopted the new text of the statute.
- the merging company succeeded according to art. 2504-bis cod. Civ., to the merged company, in all properties, material and immaterial, possessory situations and actions, rights, contracts, lawful interests, expectations, benefits, credits, rights, shares, assets in general, even pending and in formation, of the merged company in properties, ownership, available assets or to which they are legitimate, towards any subject even public and from any source.

All the goods and rights are acquired by the merging company with all pertinences and accessories, with all privileges and warranties even real (which will maintain the actual validity and degree), rights, responsibilities.

As a result of the merger and correspondingly, the merging company succeeds "ipso iure" in all liabilities, debts, duties, obligations, responsibilities, burdens, granted warranties, liabilities in general of the merged company, in all juridical relationships, agreements, policies, securities, deeds and trades even preliminary, even pending and in formation, disputes of every kind, towards any subject and coming from any source.

To come to a conclusion, on 31 December 2006 the merging company "FILIVIVI S.r.l." succeeded as universal successor in all goods, rights, contracts of "Lanerossi Filati S.r.l." that on 31 December 2006 ceased.


